
Call to Order

Public Comment:

Review and Approve the Minutes of the December 13, 2024 Board meeting.

New Business:

1. Authorize the hiring of Womack & Company to perform the 2024 audit of the Appraisal District at an estimated cost of \$ 14,000.00 or less as per our approved 2025 budget.
2. Discuss and act on granting the Chief Appraiser authority during 2025 to place Public Announcements in the Kingsville, Texas newspaper as required by law at a cost not to exceed \$ 3,000.00 for the year.
3. Discuss and approve the District's 2025 Investment Plan.
4. Appoint Mr. Thomas G. Denney as the Appraisal District Investment Officer for 2025.
5. Receive and approve 2024 4th quarter Public Investment Report.
6. Receive the District's 4th quarter 2024 - 25.25(B) Appraisal Roll change report.
7. Authorize the Chief Appraiser upon the maturity of one-year CD # 61989 maturing 2-3-2025 in the amount of \$ 104,363.80 plus accrued interest and additional funds to be invested into a new one-year CD. \$100,000 placed in a 90-day CD 1-7-2025.
8. Designate the Texas Association of Counties or The Texas Association of Appraisal Districts as authorized vendors to teach the Public Finance officer Training class.
9. Discuss and act on Authorization to pay current Bills.
10. Conduct Annual Evaluation of Chief Appraiser.



Chief Appraiser's Report:

1. The appellant brief prepared by Judy Hargrove on the Kenedy County-Wide Common School District lawsuit with Comptroller's offices was filed December 12th. The appeal will be heard by the new 15th court of appeals that was established effective September 1, 2024. No other new information is available.
2. Tentative date for Trial of King Ranch Lawsuits has been set for September 30, 2025. It is being scheduled for a jury trial. The Legal firm of Low Swinney Evans and James will be co-counsel.
