Chief Appraiser's Report:

1. The appellant brief prepared by Judy Hargrove on the Kenedy County-Wide Common School District lawsuit with Comptroller's offices was filed December 12<sup>th</sup>. The appeal will be heard by the new 15<sup>th</sup> court of appeals that was established effective September 1, 2024. No other new information is available.
2. Senator Hinojosa's bill SB 1605 to provide relief for Appraisal Review Board Productivity value decisions on the Comptroller's PVS studies failed to get a committee hearing following intense opposition from the Comptroller's office. It died in committee.
3. Tentative date for Trial of King Ranch Lawsuits is still set for September 30, 2025. Discovery exchanges are ongoing.
