Chief Appraiser's Report:

1. The appellant brief prepared by Judy Hargrove on the Kenedy County-Wide Common School District lawsuit with Comptroller's offices was filed December 12th. The appeal will be heard by the new 15th court of appeals that was established effective September 1, 2024. No other new information is available.

2. Mediation is set for August 7, 2025, with the King ranch in Sinton, Texas. The mediator is Mr. Joel B. Johnson
3. Tentative date for Trial of King Ranch Lawsuits is still set for September 30, 2025. Discovery exchanges are ongoing.


